Guidance

To keep our school a safe environment and to ensure staff are aware of all aspects of drugs related incidents the following guidelines are in place: -

- A policy for the Administration of Medicines.
- Administration of medication form.
- PSHE curriculum planning which is cross-curricular, following QCA guidelines.
- Specific issues statement.
- Managing drug related incidents procedure.
- Drugs, alcohol and tobacco programme of study.

Specific Issues Statement

We ensure any specific issues are dealt with through our procedures, relating to administration of medication and those supporting any member of the school community with regard to drugs issues.

Equal Opportunities

We aim to provide a safe environment for all who work and learn at Abbey School. Procedures are in place to maintain guidance and support as required.

Special Educational Needs

Any child who has a special need is catered for through our planning and procedures.

Health and Safety

Ensure we have safe procedures in: -

- Dispensing medicines to pupils.
- Security of medicines kept in school.
- Procedures for contact with parents: - i.e. consent/loco parents.
- Reporting and recording incidents/action and further support if required.
- First Aid procedures.
